

GROWING DEMAND IN A THRIVING INDUSTRY

We are a healthcare franchise whose primary platform is physical therapy, with the addition of balance, vestibular, and fall prevention therapies, but our services also extend into ancillary services, including audiology, wellness, and more.

GROWING DEMAND FOR PHYSICAL THERAPY

In 2020, approximately 56 million people were older than 65, forecasted to increase to 95 million by 2060. Of the individuals older than 65, 70% have two or more chronic conditions, 30% experience joint pain associated with arthritis, and 25% fall every year often leading to hip fractures. Physical therapy is positioned to play an important role in care, recovery, and preventative measures.

THE \$65.4 BILLION PHYSICAL THERAPY INDUSTRY

The physical therapy industry in the United States is estimated at \$65.4 Billion in 2025 with a forecast growth of 10.1% to an estimated value of \$128 Billion by 2032. The demand for physical therapists is projected to grow 15% between 2022 to 2032.

INNOVATING THE PHYSICAL THERAPY INDUSTRY

35% of adults over age 40 demonstrate a form of vestibular dysfunction when tested with a postural metric. FYZICAL brings innovation to the industry through our proprietary fall prevention, balance and vestibular rehabilitation therapies known as the FYZICAL Balance Paradigm.



WHY FYZICAL?

BALANCE THERAPY IS A MAJOR COMPETITIVE ADVANTAGE

- More than 10 million people go to the doctor for dizziness each year, but finding specialized balance therapy services can be difficult.
- BPPV is a common cause of dizziness, but many physical therapists aren't trained in what to do if the cause is something else.
- FYZICAL is different because we've developed *The FYZICAL Balance Paradigm* as well as a *Sensory Mismatch Theory*, both of which contribute to a comprehensive vestibular program that identifies and treats many causes of dizziness.
- We're able to identify numerous sensory mismatches, and provide patients with the appropriate care.
- FYZICAL always keeps its services updated to meet current market trends. For instance, consider how we've recently rolled out telehealth services to better assist our balance patients.

FURTHER REASONS TO CHOOSE OUR INDUSTRY

A GROWING DEMAND FOR OUR SERVICES: Today, Americans age 65+ make up about 15% of the population. It's estimated that they'll make up about 25% of the population by 2060, while the number of 65+ adults will triple. This increased patient base, as well as the shift in the healthcare industry towards care coordination and managing patient ailments prior to the onset of more acute symptoms, has dramatically increased the interest of investors in physical therapy.



A FRAGMENTED MARKET SHARE: Ours is a fragmented industry with no clear leading companies. Our work in the industry has led us to operate under the understanding that 20 of the largest providers capture roughly 21% of market share. That means the large majority of outpatient clinics are "mom and pops." This spells great opportunity for FYZICAL investors who are able to leverage our time-tested business model and far-reaching support network.



HIGH-VALUE BUSINESSES: We've observed that healthcare businesses often sell for higher multiples in today's market – the timing is right to break into the industry before prices surge even higher.



A BUILT-IN EXIT STRATEGY: Along the same lines as the points above, FYZICAL takes extra steps to build value into our locations so that our partners can expect to sell their businesses for a high amount. A reputable brand name, loyal customer base, strong referral management programs, and strong local reputation all go a long way towards creating a valuable business. While many of our partners stay in business with FYZICAL for many years, having an exit strategy ready comes in handy when they begin to consider retirement.



LOW-COST INVESTMENT: FYZICAL makes it easy to break into the industry with a low barrier to entry – the cost to open one of our locations is typical around an initial investment of approx. \$400k.



REAL ESTATE REQUIREMENTS: Flexible real estate requirements make it possible to open a wellness business just about anywhere in your community. When you partner with FYZICAL, we'll do some demographic research on your area to decide where it would be best to set up shop. Oftentimes, it's not difficult to find a location that meets all of our criteria.


THE INITIAL INVESTMENT

The total initial investment in a FYZICAL clinic will likely run between **\$217,850 – \$518,600**. The exact amount you'll end up investing will depend on a number of variables, such as where your clinic will be located, how many services you'll initially offer, and so forth.



THE INITIAL FRANCHISE FEE

Included in your total initial investment is a one-time franchise fee of \$49k. Like other franchisors, FYZICAL assesses this fee to help offset some of the costs associated with your onboarding. Your initial franchise fee grants you access to our trusted brand name and time-tested business model, both of which will save you substantial time and resources as you grow your business.



ROYALTIES

FYZICAL ensures that our partners have access to the best resources to help them grow their businesses. In return, our franchisees provide a monthly royalty payment, which comes to 6% of your gross monthly revenue.
